Verbal abuse includes, but not limited to; challenging the referee's calls either during or after a match, taunting, saying anything negative including foul language, showing disrespect or 'upstaging' the referee.

Managers are responsible for their team's behavior, including all invited guests or family members. Should the team manager have an issue with the behavior of their team members or invited guests, they should ask the acting field marshall to have them removed from the playing field before and after a scheduled match or during a match have the governing referee to hault the game and have them removed from the playing field.

Managers and players should encourage showing respect towards the league, staff organizers, referees, opposing managers and all players. Arguing calls made against your team, or arguing calls *not* made against the other team in your opinion, or blaming losses on the referee does not project earning respect from your team. At no time should the manager of a team or player approach the referee to openly challenge their calls or make comment of his/her displeasure of the referee's abilities. You must have the personal discipline to walk away from any aggressive or hostile situations whenever possible.

Any blatant disregard of TRSG Zero Tolerance Policies will result in league suspensions, fines and even league expulsion. Your feedback is welcomed by the league in its appropriate time and demeanor.
